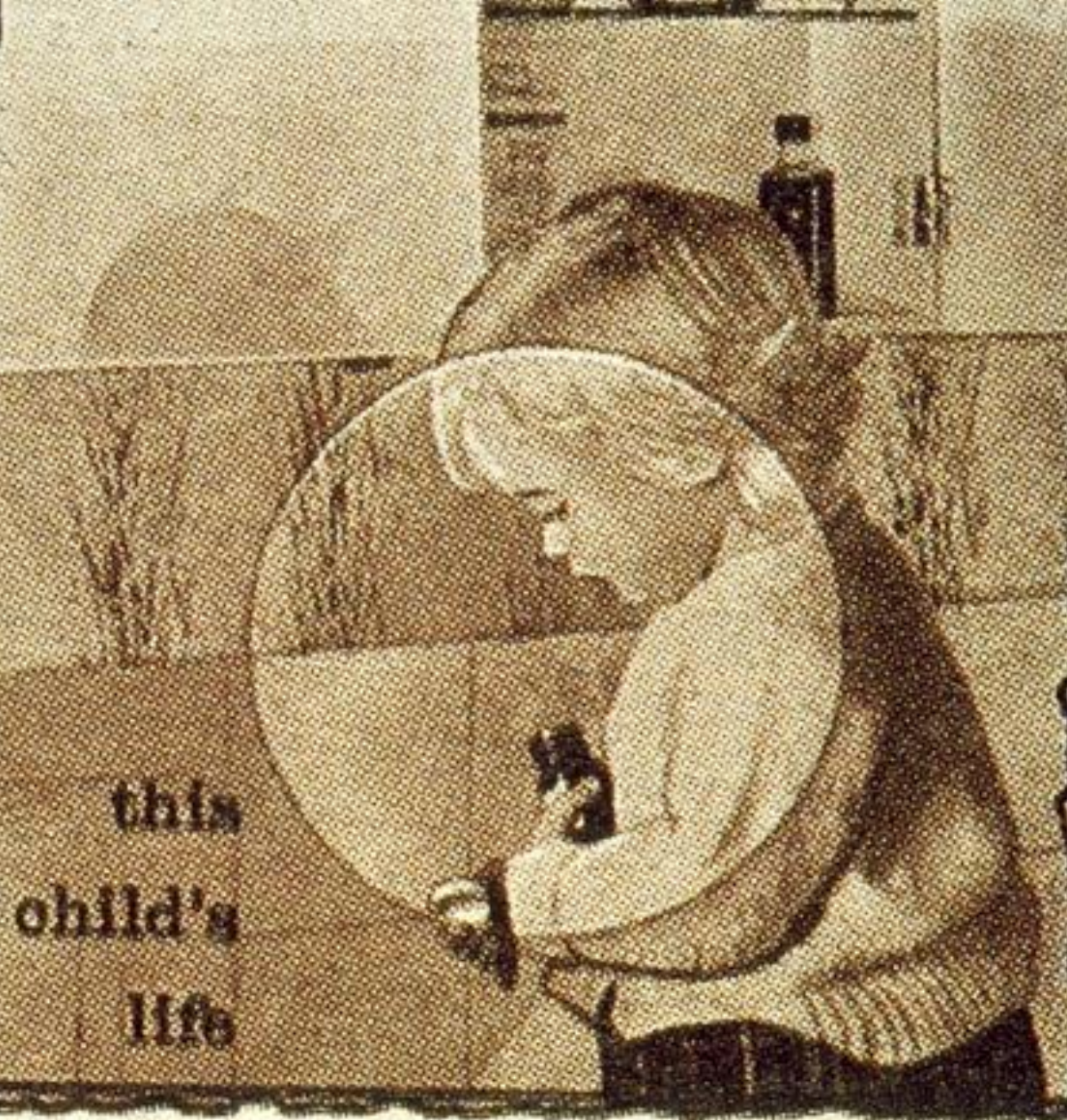

Modern version of Hippocratic Oath

A widely used modern version of the traditional oath was penned in 1964 by Dr. Louis Lasagna, former Principal of the Sackler School of Graduate Biomedical Sciences and Academic Dean of the School of Medicine at Tufts University

I swear to fulfil, to the best of my ability and judgment, this covenant:

I will respect the hard-won scientific gains of those physicians in whose steps I walk, and gladly share such knowledge as is mine with those who are to follow.

I will apply, for the benefit of the sick, all measures [that] are required, avoiding those twin traps of overtreatment and therapeutic nihilism.

I will remember that there is art to medicine as well as science, and that warmth, sympathy, and understanding may outweigh the surgeon's knife or the chemist's drug.

I will not be ashamed to say "I know not", nor will I fail to call in my colleagues when the skills of another are needed for a patient's recovery.

I will respect the privacy of my patients, for their problems are not disclosed to me that the world may know. Most especially must I tread with care in matters of life and death. If it is given to me to save a life, all thanks. But it may also be within my power to take a life; this awesome responsibility must be faced with great humbleness and awareness of my own frailty. Above all, I must not play at God.

I will remember that I do not treat a fever chart, a cancerous growth, but a sick human being, whose illness may affect the person's family and economic stability. My responsibility includes these related problems, if I am to care adequately for the sick.

I will prevent disease whenever I can, for prevention is preferable to cure.

I will remember that I remain a member of society with special obligations to all my fellow human beings, those sound of mind and body as well as the infirm.

If I do not violate this oath, may I enjoy life and art, be respected while I live and remembered with affection thereafter. May I always act so as to preserve the finest traditions of my calling and may I long experience the joy of healing those who seek my help.

A Medical Information No – rarely listed.

DTC Ads No - But don't connect to GSK.

Journal Ads No - But don't reach GSK directly.

DTC Ads offer medical information through a call center – but this is not a medical information center, nor the GSK Customer Response Center call center.

Paxil CR's toll free no. now reaches Neevo Plus - a different Co.
Paxil's DTC numbers just ring.

If AW left a voice message, it is almost certain that no one called her back as she had not reached GSK.
Hence her email pleas for a response?

Companies now refer you to FDA's Medwatch & "Talk to your Doctor".

Companies have to follow up on adverse event reports.
Communication from patients could change their warnings.

Medwatch does not follow up on adverse events.
Reports to Medwatch makes action on adverse events less likely

Diverting reports to the regulator saves money, reduces legal liability and relegates them to the status of anecdotes

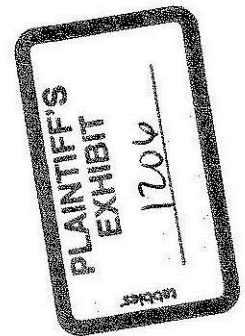

THALIDOMIDE* is the generic name for N-phthalyl-glutamic acid imide, a compound which has been employed in Europe for several years as a sedative-hypnotic. It is chemically related to glutethimide (Doriden), another sedative-hypnotic, and to bemegrade (Megimide), a convulsant analeptic.

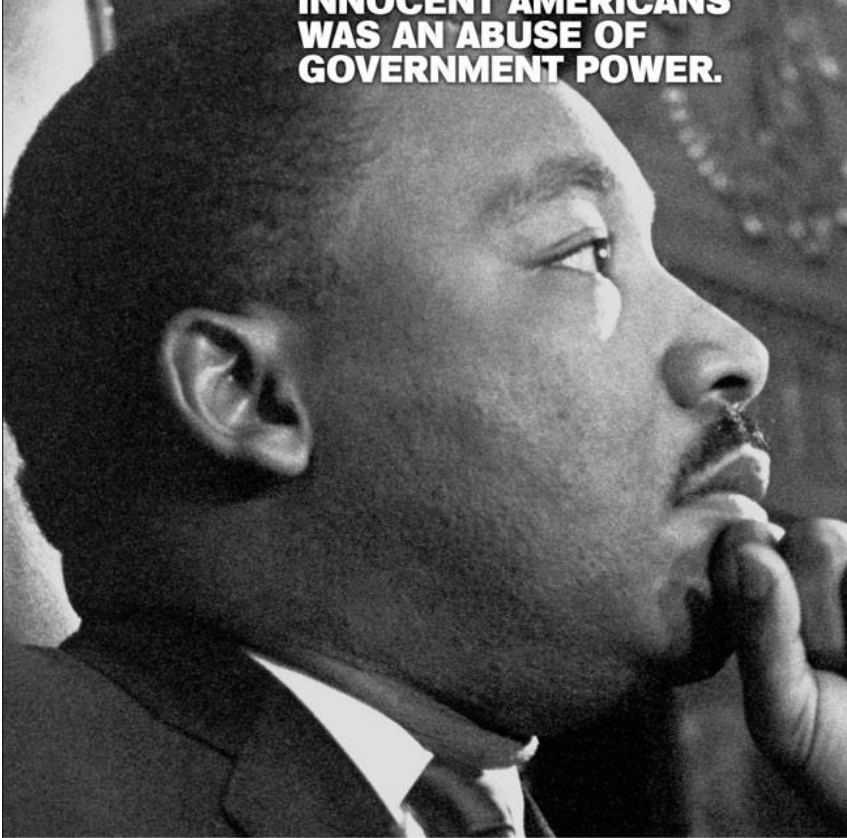

APA Responds to FDA's New Warning on Antidepressants

“The American Psychiatric Association believes that antidepressants save lives.”

big with consequences, including an increased risk for suicide. The worst case biggest threat to a depressed child's well-being is to receive no care at all.

We restate our continued deep concern that a “black box” warning on antidepressants may have a chilling effect on appropriate prescribing for patients. This would put seriously ill patients at grave risk. Recent prescription data suggest the current controversy over antidepressants has already lowered treatment rates; the new black box warning may further negatively impact treatment rates. The APA is working to help mitigate such an impact by collaborating with non-psychiatric physicians – including pediatricians and general practitioners – to help them better understand their patients' needs and properly diagnose, treat and monitor patients. Additionally, we hope the FDA will set in place a system to track the impact of the black box warning on prescribing patterns. This system should also track any increase in actions by patients to harm themselves as a result of reduced access to medically necessary treatment with antidepressants.
